


John Horton also announced that he will take orders for club name badges. Contact him at 843-1399.



SAMPLE LETTER TO YOUR SENATOR or REPRESENTATIVE

I am deeply concerned about the pending legislation on air quality. Singling out "old cars" is not the only answer to the problem, nor is the new IM40 testing the answer. You willonly succeed in having more people register their cars out of Arizona. Any more restrictive legislation will kill a Special Interest Car market in Arizona that is unique to our state and worth almost a billion dollars annually to our economy.

Why do I see School buses spewing black fumes, construction equipment with clouds of diesel smoke and particulate matter? What about the tons of air pollution from pesticides? One oil refinery in Maricopa spews out over 170 tons of pollution every year! Why is this allowed while the legislators harp on "old cars"?


There are 1300 flights a day out of Sky Harbor airport. Commercial jets sit and idle for 45 minutes between flights. What consideration is given to the background count and basic air quality in Arizona? Do the Federal EPA guidelines require us to return the Arizona air quality to pre-human habitation levels?

What does it take to convince the EPA that we are doing as much as possible? After all, we were "out of compliance" for only two days in one year. Why is our state being singled out? Is Washington trying to make an "example" of Arizona? Let us say "NO" to the EPA - we did so on MediCare and Arizona is still solvent. When will you stand up to them?

We elected you on the promise that there would be less and simpler government, but we are getting more and more regulations. You are in office to represent the citizens of your state, not the powers of Washington.

There are more than 150,000 classic and special interest automobile owners in Arizona. We keep these classics in excellent condition and most are driven sparingly. According to recent newspaper articles, automobiles account for only 35% of Arizona's air pollution problem.

We, the owners of classic and special interest cars, DO NOT WANT MORE RESTRICTIONS! We want representatives who listen to us! Please consider our position (and our collective voting power) when you vote on these bills.

I have been trying for over a week to finish this issue and go to press, but things have been moving so fast at the Capital that I have waited until the last minute to see what changes would be made. It has been a frustrating month. Remember back in March, there was a big movement to include vehicle scrapping in the Clean Air Act, but was removed before HB2129 was passed. I would like to believe that the many calls to legislators helped stop the

Since the beginning of September when the new hearings started, everyone testified against including Vehicle Scrapping in the bill. At the same time the news media ran big headlines about vehicle registration fees being based on amount of emissions. Also that old cars would be charged \$300 registration fees. All of this was presented as a "red herring" to direct attention from the problem, which was IM-240! In fairness, no one wanted IM-240 either. However, this is the big item pushed by the EPA, as stated elsewhere, it is expensive, slow, and the car dealers don't have enough trained people. Besides this is for 1981 and newer cars which we are told don't pollute! (If it were not so serious, I could laugh) At the final days of the hearing, the legislators also spoke out against vehicle scrapping, including both co-chairpersons. One senator even called a news conference to state that picking on old cars was being directed against poor people.

VEHICLE SCRAPPING RETURNS

The special session for this clean air bill should start on the 4th of October. The IM-240 provision has been killed, to be replaced by a "Vehicle Scrapping Program!" Why the sudden reversal? What happened to all those that were against it?

Perhaps our legislators are not aware of what it will do to the economy. Perhaps the BIG question is where is the state going to get the money? This has not been worked out yet. Does the Governor think the state can afford to finance it when they do not have enough money for the general fund?

More than one lobbyist has said to me, "What are you concerned about? This is a voluntary requirement." "B.S." I can't think of any requirement that could do more harm!

However.... It's not over 'till it's over! This could be a time for YOU to act. I have included a list of all Legislators with their phone numbers. Remember that most of them either do not like vehicle scrapping, or are unaware of the opposition. If you decide to phone, call YOUR legislator.

SENATOR KEITH BEE AGAINST SCRAPPING

Senate Transportation Committee Chairman, Keith Bee is vehemently opposed to any Vehicle Scrapping Program, for the following reasons: - improves air by only .5% - would cost the state \$7 million - only registered vehicles that fail emissions would qualify - If ALL pre-'80

cars were removed from the road it would not meet EPA requirements
